- 1.0 Call to order:** President Bugni called the meeting to order at 5:00 p.m.

- 5.0 Approval of previous meeting's minutes:** Motion by Lutgen, seconded by Warren , to approve the meeting minutes from the Monday, August 12, 2024 meeting as corrected. Motion carried unanimously
